Professional accountants and auditors working in practice and industry, who are qualified in accordance with national accounting standards, are eligible to take the qualification.

You will need to prove that you have one of the following:

- Two years' relevant accounting experience and a relevant degree (accounting)
- Three years relevant accounting experience
- ACCA Affiliate status

Exam Overview

Assessment:

DipIFR is assessed by a three-hour and 15 minutes Computer-Based exam held twice a year,

June and December at ACCA's exam centers with a pass mark of 50%.

Marks: 4 x 25 Mark Questions
Total:100

The Examination is organized by the ACCA.

The exam requires a mix of calculations and written answers.
