## 7. Terms of Enrolment

---

**Course registrations for the January – June 2024 semester have officially started!**

### 1. Terms of Enrolment

To be eligible to attend the UNIC Global Training ACCA courses and be granted access to the Moodle Platform, and study material, students must complete the enrolment form and ensure that fees from previous term(s) are fully settled.

Students who are already ACCA students must also provide their ACCA registration number on the online enrolment form.

Students joining any course late will be allowed to have access to the recorded lectures, through the UNIC Global Training Moodle Platform.

### 2. Drop Forms

A student/participant wishing to withdraw from any course(s) **must complete** the online drop form (which can be found on our website under the “[Useful Links](#)”). **The date on which the Drop Form is completed by the student will be the date of withdrawal.**

Students dropping a course, after its commencement, will be charged a fee based on a **pro-rata basis**, subject to a **minimum administrative charge of €100**. Students **who drop** the paper eight weeks before the end of the course will be charged the full fee for the paper.

### 3. Access to recorded sessions

Enrolment in UNIC Global Training courses will be valid until the exam date of the current semester. After the exam date, access to recorded sessions will be unavailable.

## 8. Terms of Payment, Special Discount Schemes & GPS

The following terms of payment apply to those students who will not opt to benefit from our special discount scheme (see below)

- 25% upon enrolment
- 25% by the end of February
- 25% by the end of March
- 25% by the end of April



- Students registered for a **Repeat/Revision** course should **settle their fees in full, upon enrolment.**
- Students whose fees are partly covered by their employers and get a discount on their share of fees **must** settle their share upon enrolment. If students are fully sponsored, should submit upon enrolment their **sponsorship letter**, and send it to [finance.globaltraining@unic.ac.cy](mailto:finance.globaltraining@unic.ac.cy)
- Students who need to vary their terms of payment should contact the finance department.

### **Special Discount Schemes**

The following special discount schemes apply:

- **8 % discount for students** who will settle their fees before or on the date of the commencement of the course.
- Where a student is eligible for more than one discount, the highest discount rate will be allowed.

**Note:** The 8% discount does not apply to revision courses.

### **Exempted papers:**

Students who are granted exemptions and wish to attend an exempted paper will be charged the respective **Repeat fee** of the paper subject to the submission of relevant documentation.

### **Guaranteed Pass Scheme (GPS)**

The Guaranteed Pass Scheme concerns students who have failed a paper in the previous semester and wish to attend the specific paper again from the beginning of the next semester.

Should that be the case and the below conditions are met, then the student will be entitled to attend **free of charge** the same paper in the following semester:

- attended at least 85% of the lectures (ground-based or Live-Online) <sup>1</sup>
- achieved at least an average score of 45% in the two Final Mocks.
- attempted the two Final Mocks as per UNIC Global Training's policies <sup>2</sup>

*\*Recorded lectures do not qualify for this scheme; students should attend the courses LIVE (either in class or Live-Online session)*

*\*\* Students must attempt the Interim and Mocks under Exam conditions (even if Live-Online)*



**Note:** Students are informed that if the GPS policy applies to them, they **still need to complete the enrolment form** for the retake paper (by choosing on the enrolment form the *Repeat*) and **have the fees of the previous semester fully settled**.

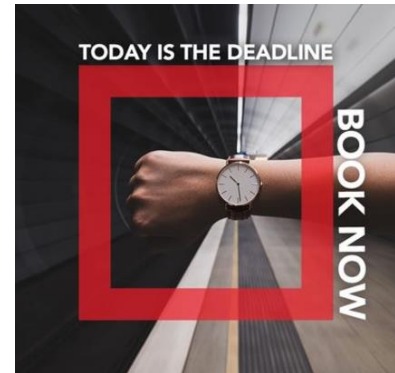
## 10. ACCA Exam Deadlines, Fees & Exam Dates

Exam Entry Registration Deadlines & Fees (Except BT, FA & MA)

Exam entry rules:

- All deadlines for exam entry are midnight UK TIME
- Exam changes can only be made **before** the standard entry
- Additional support may be requested **before** the standard entry
- Exam dockets will be made available 2 weeks after standard entry (**myACCA**).
